The Alberta School Councils' Association (ASCA) recently held its in-person provincial conference and hybrid Annual General Meeting (AGM) April 26-28, 2024. Thank you again for speaking to our 200+ delegates from across Alberta and answering their questions. We deeply appreciate your sincere efforts to build connections with parents on school councils and support their learning from multiple inspiring leaders on a wide range of education related topics.

On Sunday, April 28th, our Annual General Meeting started at 8:00 a.m. A total of 157 ASCA Member School Councils were represented for the majority of the 11.5-hour AGM. I have included a copy of the Advocacy Resolutions discussed at the 2024 AGM, identifying those carried into Advocacy Policy of the Association. ASCA Members requested several of your colleagues also be made aware of some of these Advocacy Policies, therefore separate letters containing the Advocacy Policies relevant to each Ministry or Official will be sent to the following, cc'd to you:

The Honourable Danielle Smith, Premier of Alberta; The Honourable Adriana LaGrange, Minister of Health; The Honourable Dan Williams, Minister of Mental Health and Addiction; The Honourable Pete Guthrie, Minister of Infrastructure; The Honourable Ric McIver, Minister of Municipal Affairs.

Provincially, the ASCA Board and Executive appreciate the opportunity to provide the advice and feedback received from parents on Alberta's legislated school councils, with respect to new and ongoing Alberta Education initiatives. We believe a collaborative process results in an enhanced education system focused on the learning success of all Alberta's students.

Your comments and feedback would be appreciated, and, as is customary, will be shared with our Members. I am pleased to respond to any questions you may have and look forward to discussing these, and other, Advocacy Policies of our Association.

Elections also occurred during the Annual General Meeting, and I am pleased to inform you that the ASCA Board has new leadership and Board members. Three (3) new Directors joined the ASCA Board: Meagan Parisian (2 Year Term), a parent from the Red Deer Public School Division; Stephanie Bugbee (1 Year Term), a parent from the Red Deer Catholic School Division; and Ismeria Bruce (2 Year Term), a parent from the Holy Spirit Catholic School Division. Kenneth Glazebrook is ASCA's new Vice President (2 Year Term), and I, Kerry Bodell, am ASCA's President (2 Year Term). Brandi Rai is officially ASCA's Past President (1 Year Term), having been affirmed in this role by the ASCA Board immediately following our AGM.

In closing, I am respectfully requesting two meetings with you prior to the end of June 2024.

I would appreciate a few moments of your time on either of those days for you to join us at your convenience, and have our Directors introduce themselves to you.
