1. Why do you wish to serve on the ASCA Board of Directors?

I have lived experience in navigating the education system with a child with a developmental disability, as well as one that identifies as LGBTQ. I want to ensure that families and students from all walks of life feel heard and represented.

2. What is your school council experience?

I have been a member of my children's school councils for the last 5 yrs. I have held positions (Chair, Secretary, Director) and have also just been a member. I recognize the value and need for school councils in affecting change within the political system of Education. I have presented as a delegation to our local school board regarding issues, and I have chaired committees that were responsible for staff appreciation, or student engagement. I have experience with being on a council for Pre-K-8, a high school (9-12), as well as a French Immersion Pre-k-9.

3. How will your greatest strength help you perform as a board member?

My greatest strength is my passion and this will support my board member performance by fueling the drive to advocate to the best of my ability.

4. What do you see as the top priority or challenge for K-12 parents in the province?

I see the reduced funding as the largest challenge for K-12 parents. Our children need smaller class sizes, more Educational Support Aides, safe and modern buildings, and access to the latest information and technology.

5. Give an example of how you have dealt with differing perspectives:

I work with small children in at-home childcare. There are frequent misunderstandings, and the way I deal with them works well for adults as well. I model a calm outer appearance, and take some deep breathes if I need to. I remind them that we are all on the same team, and that all feelings matter. I then say who will tell their side first, and who is next. Then I ensure there are no interruptions when someone is speaking so that everyone has the opportunity to share their point of view. Once everyone has spoken I sum up what I have heard/how I understood and ask for clarification. Generally discussion continues smoothly after that.

6. Have you reviewed the time commitment required to be a Director? Yes How do you see yourself

balancing your professional and personal life to manage the duties of a board member?

My husband and children are very supportive of my volunteer obligations, as well as my dayhome families as they know that the time I spend advocating will benefit their families as well. As long as I have a schedule of meeting dates in advance I can make the necessary plans so that I can attend.

I do not believe so. I do not have any affiliations within Education aside from being on our school council and occasionally driving a bus for students. I am an employee of the school district, but just within Transportation and am very casual.
